Membership Classes and Qualifications:

RESIDENT MEMBER: Candidates for Resident Membership must be at least 40 years of age. Candidates must be persons of good moral character. **Monthly Dues \$381**

JUNIOR 2 MEMBER: Candidates for Junior 2 Membership must be between the ages of 30-39 years. Candidates must be persons of good moral character. Upon reaching the age of 40 years, a Junior 2 Member shall automatically become a Resident Member and be required to pay balance on Initiation Fee, if applicable, and Resident dues beginning the month following his birth month.

Monthly Dues \$269

JUNIOR 1 MEMBER: Candidates for Junior 1 Membership must be between the ages of 21-29 years. Candidates must be persons of good moral character. Upon reaching the age of 30 years, a Junior 1 Member shall automatically become a Junior 2 Member and be required to pay balance on Initiation Fee, if applicable, and Junior 2 dues beginning the month following his birth month.

Monthly Dues \$168

NON-RESIDENT MEMBER: Candidates for Non-Resident membership must be at least 21 years of age and must not maintain a residence (principal) within the local residence area. The local residence area consists of the City of Danville and adjacent territory within 30 miles of the City's boundary. Monthly Dues \$183

NATIONAL NON-RESIDENT MEMBER: Candidates for National Non-Resident membership must be at least 21 years of age and must not maintain a residence (principal) within one hundred (100) miles of the local residence area. The local residence area consists of the City of Danville and adjacent territory within 30 miles of the City's boundary.

Monthly Dues \$123

SENIOR MEMBER: Candidates for Senior Membership must be at least 75 years of age. Candidates must be persons of good moral character. **Monthly Dues \$311**

Community Service Membership (CSM)

Rewarding and acknowledging those that make our community a better, safer place to live.

Danville Golf Club is excited to announce our newest membership category, the Community Service Membership. Danville Golf Club has been the premier private club in the community for over 100 years, and as a prominent corporate member of the community the Club has both an opportunity and obligation to support those who support us all. The Community Service Membership category is designed to reward and acknowledge individuals who work daily to make our community a better and safer place to live. Below you will find the details regarding this limited new category.

- Eligible professions include those who are employed full time in education, active military or reserves, law enforcement, fire department, lifesaving crew, clergy, the medical community, and Disabled Veterans with a disability rating of 30% or more from the Veterans' Affairs Administration (with valid proof).
- **50%** reduction in current dues structure with family total income (1040-line 9) less than \$150,000.
- **25%** reduction in current dues structure with family total income (1040-line 9) greater than \$150,000 but less than \$200,000. Greater than \$200,000 receives no reduction.
- This category will be limited to the first 50 new members.
- Qualifying applicants for this membership category are excluded from any other membership campaigns and/or dues/food credits.
- Normal application procedures apply in addition to submitting the first page of IRS form 1040 and W-2 form for employment verification. Pay stub will be accepted in place of W-2 form if it is the first year in current CSM qualifying job. IRS form 1040 and employment verification will need to be submitted yearly as well to retain the special dues rate. *The Danville Golf Club Business Manager will be the only one to see IRS form 1040 and form W-2 and approve for CSM, pending the Board approval. The Board will receive only the standard application information for vote.*
